PRICE LIST

For using the facilities of the Split City Museum for the year 2022

- The Gallery of the Split City Museum, Dioklecijanova bb and the venue for temporary exhibitions:**
 - one day (using the facility for up to 7 days) 33,18 EUR 250,00 HRK
 - one week..... 165,90 EUR 1.250,00 HRK
- Gothic venue of the Split City Museum, Papalić palace**
 - using the 70 -100 square metre space, depending on the type of event
 - seating capacity for 70-100 people
 - technical equipment: projector, laptop, projector screen, speaker, podium
 - the event organizer may organise catering
 - using the space for 1 hour..... 132,72 EUR 1.000,00 HRK
 - each hour of using the space for up to 2 hours.....
..... 132,72 EUR 1.000,00 HRK
 - third hour of using the Gothic venue is free
 - every hour after the fourth hour..... 265,45 EUR 2.000,00 HRK
- Split City Museum – Papalić Palace Large Courtyard**
 - 50 square metre space, up to 40 standing and/or seating places, combined depending on the type of event
 - technical equipment: projector, projector screen, speaker, podium
 - the event organizer may organise catering
 - catering option which is organised by the program organizer
 - appropriate for weddings, special occasions photography, fashion shows, presentations, by arrangement
 - an hour of using the space..... 132,72 EUR 1.000,00 HRK
 - two hours of using the space..... 398,17 EUR 3.000,00 HRK
 - using the space from 3 to up to 5 hours..... 663,61 EUR 5.000,00 HRK
- The Diocletian Palace Substructures - venue 6A**
 - **a representative three-nave venue with apse, 300 - 400 square metres, arched**
 - has the capacity of **250-300 people** depending on the event – whether standing or seating places are planned
 - the venue is appropriate **for various events**: gala dinners, banquets, presentations and lectures, concerts, plays, fashion shows...
 - **the organizer brings and takes away all equipment**
 - the terms of use are defined **by safety and conservation provisions**, and they are constituent parts of the obligatory contract which regulates the rights and obligations of the Museum and the organizer
 - an hour of using the space..... 796,34 EUR 6.000,00 HRK
 - **every fourth hour is free**

5. The Diocletian Palace Substructures - venue 4A

- using the space of **100 - 150 square metres**
- **100-150 people** capacity depending on whether standing or seating places are planned
- the venue 4A often facilitates the event in the venue 6A
- this space has a **rectangular shape and is connected to venue 6A**
- as such it is usually used as an auxiliary room for cultural events or as a room for supplying food and drinks at dinner parties
- the terms of use for the event organizers are defined according to the safety and conservation provisions and they are constituent parts of the contractual obligations accepted by the Museum and the organizer
- one hour of using the space..... 530,89 EUR 4.000,00 HRK
- **Every fourth hour is free**

Note: The listed prices for using the facilities are subject to **increase for preparing, cleaning and using outside of working hours of the Museum.**

General notes:

- Said prices are exempt from VAT.
- The spaces in the Papalić palace must be booked at the latest by the 15th of the preceding month.
- Booking the Diocletian Palace Substructures is possible at least two months in advance.
- The prices for specific services which are not defined by this price list are determined for each individual case.
- Prices are shown in Croatian kuna and EUR.
- For services which have extraordinary material expenses, the price for using the facility is increased by the amount of the expenses.
- The organizers are required to follow the safety and conservation provisions which they must be familiar with and notify the users of the spaces, the members of the event.
- The Museum may terminate the contract for failure to comply with the provisions.
- The Decision on Using the Facilities of the Split City Museum is applied when the facilities are used without payment in accordance with the Conclusion by the Mayor of Split.
- Using the facilities must not disturb museum visitors.
- For the purposes of dual display of prices and other monetary values, the prescribed fixed conversion rate is used, EUR 1 = 7,53450 HRK.

Admission fees are applied from 5th September 2022.
